RULES AND REGULATIONS OF THE SOCIETY

1. Name : ANDHRA CHRISTIAN COLLEGE ALUMNI ASSOCIATION,
G U N T U R
2. Location : Located in the campus of A.C. College, ^{G Samba campus,} Guntur. _X
- ARTICLE - I : Membership .

Section 1 - Eligibility:

Any former student who has completed at least one academic year in the college shall be eligible for membership of the Alumni Association. No member of the college who is still prosecuting any sort of studies at the college is eligible to become a member.

Section-2:

There shall be four categories of membership:

- a. Active Members: Those alumni who pay an annual subscription of Rs.15/- shall be active members of the Association.
- b. Life Members: Those of the alumni who pay a lumpsum of Rs.150/- shall be life members of the Association.
- c. Donor Members: Those of the alumni who pay in a lumpsum of Rs.500/- and more shall be donor members.
- d. Associate Members: Any person who is not a former student of the college, can be enrolled as Associate member by paying Rs.15/- per annum) and the membership is subject to the approval of Executive Committee.
- e. Honorary Members: The Executive Committee of the Association shall nominate honorary members from among the faculty and administration of the college and others who have done distinguished service to the Alumni Association and the college.

Section - 3 :

Life and donor membership fees shall be kept in a long term fixed deposit and the interest accrued thereon shall only be utilised for the expenses of the Association. The corpus fund thus constituted shall not be touched under any circumstances for any purpose.

5. TREASURER: The treasurer is responsible for all the financial transactions relating to the Association. He has to maintain the accounts properly ✓ He has to operate the Bank Account jointly with the Executive Secretary.

ARTICLE - IV : (Executive Committee and other committees)

Section -1 : Membership: The Executive Committee shall consist of the following members: a. Twelve members elected by the General body of the Alumni Association, from among the active, life and donor members, b. The Office-bearers of the Alumni Association, c. Any member coopted by the Executive Committee, in the best interests of the Association. The Executive Committee shall consist of atleast three women.

Section:2. The term of Office of all the elected members shall be two years.

Section:3. Election of members: The members shall be elected at the General body meeting of the Alumni Association every two years.

Section:4. The Executive Committee of the Alumni Association shall be the Governing Body of the Alumni Association.

Section:5. Meetings: The Executive Committee shall hold atleast two meetings during an academic year. Additional meetings of the Executive Committee may be convened as and when necessary with the approval of the President. Requisitioned Meetings: If seven members of the Executive Committee make a written request, stating the subject to the president a special meeting of the Executive Committee shall be convened.

Section:6. i. Quorum: Seven members shall constitute a quorum of the Executive Committee. ✓

ii. The quorum for the general body meeting shall be one fifth or fifty of the members enrolled. ✓

Section-7. Sub-Committees: The Executive Committee of the Alumni Association may appoint any committee, if required.

ARTICLE - V. (Meetings):

Section-1. Annual Meeting: The Annual meeting of the Alumni Association shall be held not later than the second saturday of September. A report on the important activities of the Alumni Association and the major actions of the Executive Committee during the preceding year shall be presented along with an audited statement of accounts for approval.

Section-2. Requisition meeting of the General body: The President of the Alumni Association may, and at the written request of one fifth or fifty members of the Alumni Association enrolled shall convene a special meeting of the Alumni Association.

ARTICLE-VI: (ACTIVITIES)

Section:1. The Alumni Association may organize seminars or conferences with a view to providing continuing education to the alumni. The services of our distinguished former students and others may be secured for this purpose.

Section:2. The Alumni Association may arrange games, competitions and other social gatherings which bring together the past and present students.

ARTICLE-VII: OFFICIAL YEAR:

The Official year of the Alumni Association shall be from 1st July to 30th June.

ARTICLE: VIII: The Alumni Development Fund for the college:

The Alumni Association shall promote an Alumni Development fund for the college to which all members shall be invited to make annual contributions.

1. Purpose: The purpose of this fund shall be:-

- a. to secure necessary finances towards the maintenance of the Alumni Association and implementation of its programme and
- b. the furtherance of the development of Andhra Christian College through financial support for selected projects. All proceeds of this fund each year shall be remitted by the Treasurer of this Association to the Burear, A.C. College, Guntur, with an audited statement of Accounts.

Sections:2. Organisation: The Alumni Association may appoint such committees or officers for the promotion of the Alumni and College Development Fund as seen advisable in consultation with the Principal.

ARTICLE IX:: NOTICE OF MEETING:

Three days notice shall be given to the members of the Executive Committee for the meeting of the Executive Committee and 15 days notice for the meeting of the General Body.

ARTICLE :X: Section: 1. Accounts:

All funds of the Alumni Association shall be in the Extension Counter of the State Bank of India located in the campus of A.C. College, Guntur. The Bank account of the Association shall be operated jointly by the Treasurer and Executive Secretary. The Auditors of the college shall be the auditors of the Association.

Sections:2. Vacancies: If any member of Executive Committee is absent for three consecutive meetings, he/she will ceased to be a member. In the event of a vacancy in any office-bearer or in the Executive Committee by reason of death, resignation or any other cause the vacancy shall be filled by the Executive Committee for the unexpired portion of the term in which the vacancy occurred.

Section:3. Elections: Elections to the Office-bearers and Executive Committee members shall be conducted ordinarily by show of hands of the members present. In the event of demand by atleast ten members it shall be by secret ballot, the procedure for the conduct of which shall be decided by the Executive Committee.

Agenda: The agenda for the Executive Committee meetings and other meetings shall be drafted and circulated by the Executive Secretary in consultation with the President. The Agenda for the General body meeting shall be decided by the Executive Committee and circulated by the Executive Secretary. Members who wish to give notice of any resolution to be moved in the general body should send the same so as to reach the Executive Secretary at least a week in advance.

ARTICLE : XI.

AMENDMENTS: The Constitution of the Association may be amended at any annual meeting of the Association or special meeting called for the purpose by a three-fifth majority vote of the members present provided that a written notice of any proposed amendment is sent to all members by mail not less than 21 days prior to the date of the meeting, as per the section 12 of the Registration Act XXI of 1960.

ARTICLE XII::

WINDING UP: In case the Association to be wound up the property and funds of the Association that will remain after full satisfaction of the liabilities of the Association will be transferred to a similar institution with the same aims and objects.
