ORDER:

In the reference first read above, the Commissioner of Collegiate Education reported that Sarvasri T. Chandra Babu and V. Prabhakar Reddy were appointed as Lecturers in Commerce, by Management of A.C. College, Guntur in the un-aided vacancies on existing work-load with effect from 14.9.1985 and 16.9.1985 respectively. Later on out of 8 posts of Lecturers 6 were to Grant-in-aid. The request of these two Lecturers for admission of their posts to aid were rejected due to introduction of the common core system for the work-load in the Degree Colleges. These two individual officers further represented for their regularisation on the analogy of similar cases approved by the Government. The individual officers also expressed their willingness to withdraw their case pending in the Court. The Special Officer reported that the names of these officers were originally submitted for admission to grant-in-aid during the year 1991.

2. Government after due consideration of the proposal of the Commissioner of Collegiate Education, hereby admit these two posts of Lecturers in Commerce held by Sarvasri T. Chandra Babu and V. Prabhakar Reddy in A.C. College, Guntur, to aid and also admit them to aid with effect from the date of issue of this order and permit the Commissioner of Collegiate Education to shift these two Lecturers with the posts to a needy college where there is sufficient work-load.

3. This order issues with the concurrence of Finance and Planning (EE) Department vide their U.O.No. 27876/1289/EE/94, Dated: 13.9.1994.
