In the reference 1st read above, the Hon'ble High Court has ordered as follows:

"Viewed by any angle, the refusal of the respondents to absorb the petitioner into an aided vacancy in botany is not sustainable. Consequently the respondents 1 to 3 are directed to accord permission to the 4th respondent to absorb the petitioner in the aided vacancy of the lecturer in botany with effect from 01.02.2001 granting such permission within four weeks from the date of receipt of a copy of this order".


2. In the reference 2nd read above, a contempt case was filed by Smt.D.Phebe Sarah, Un aided Lecturer, AC College, Guntur.
3. The Government taking into consideration all the aspects of the case including the orders prevailing on the date vacancy has arisen, conditions existing as on that date to fill up that vacancy eligibility of the candidate and methodology to fill up that arising vacancy, Government have decided to comply with the orders of the Hon'ble Andhra Pradesh High Court in WP No.20036 of 2003 dt:30.10.2013 subject to outcome of SLP filed by the Government.
4. The Special Commissioner of Collegiate Education, Andhra Pradesh, Vijayawada, shall take further action accordingly.
5. This order should not be quoted as a precedent in respect of any other case.
6. This orders issues with the concurrence of Finance department vide their U.O.Note 32026/112/A2/HR.III/2017, dt.5.12.2017.
